Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We projected that carbon emissions will decrease over the next five years to 3.22 tonnes CO₂e by 2027. This is a reduction of 25%. We are currently ahead of this target.

Carbon Reduction Projects

In the future we will continue to develop and implement measures such as:

- Improved sustainable travel policy;
- Review of hybrid working model; and
- Review of requirement for managed office space.
